SHALL THE FOLLOWING BE ADOPTED?

SHALL THE BOARD OF COUNTY COMMISSIONERS OF STEVENS COUNTY, KANSAS, BE AUTHORIZED TO ISSUE GENERAL OBLIGATION BONDS OF THE COUNTY IN AN AMOUNT NOT TO EXCEED \$3,525,000, TO PAY THE ESTIMATED \$3,525,000 COSTS TO ACQUIRE AND CONSTRUCT A LIMITED CARE RESIDENTIAL FACILITY IN THE CITY OF HUGOTON, KANSAS, INCLUDING (I) A 27,860 SQUARE FOOT BUILDING WITH 15 RESIDENTIAL UNITS, A COMMERCIAL KITCHEN, DINING AND OTHER COMMON AREAS, (II) ADJACENT DRIVES AND PARKING AREAS, (III) FURNISHINGS, APPLIANCES AND EQUIPMENT, (IV) LANDSCAPING AND (V) MAKING ALL OTHER NECESSARY IMPROVEMENTS APPURTENANT THERETO (THE "PROJECT") AT AN ESTIMATED COST, INCLUDING FINANCING, OF \$3,525,000, ALL PURSUANT TO THE PROVISIONS OF K.S.A. 10-101 ET SEQ. AND K.S.A. 19-4601 ET SEQ., AS AMENDED? THE BALANCE OF THE COSTS SHALL BE PAID FROM AVAILABLE FUNDS OF THE COUNTY.
